RVCP has also seen great success in our Harper's Place program thanks to an amazing staff led by Sam Palan and Steven Pfingsten. The Harper's Place team is dedicated to quality services and has developed a high-quality program to assist those in Rock County that are experiencing a mental health crisis.

The Veterans Department also continues to transform lives under the leadership of Lance Baskin and his amazing group of talented staff. In 2022 RVCP with the support of the VA, WHEDA and Hendricks Family Foundation, was able to complete renovations our Veterans Transitional Housing Expansion Wing. RVCP now offers 48-

single occupancy suites for our homeless veterans program.

To date we have served close to 600 homeless veterans!

I am proud to have joined the RVCP Family and honored to serve as the Executive Director. As leader I will manifest through my 8 core values: Integrity, Teamwork, Communication, Humility, Empowerment, Accountability, Respect, Resilience.

ABOUT RVCP, INC.

**RVCP, INC. IS A PRIVATE NON-PROFIT AGENCY SERVING THE GREATER ROCK COUNTY ,
WISCONSIN AREA.**

1971

When it all started.

A group of community members had a vision to help those returning to our communities following incarceration transition back into society. The vision was based on the concept that giving parolees transitional assistance could help prevent future involvement in criminal activities.

1988

RVCP, Inc. opened a State of Wisconsin licensed substance abuse outpatient clinic. Originally the clinic only served adults that were involved in the correctional system.

1998

Through the generosity of a previous board of directors member, the late Ken Hendricks, RVCP was relocated to the Caravilla Education and Rehabilitation Center at 203 W. Sunny Lane Road, Janesville, Wisconsin.

2010

In 2010, Caravilla, Inc. was developed to purchase the property at 203 W. Sunny Lane Rd.; opening doors for diversifying RVCP's programming and opportunities to secure capital grants to renovate the remaining vacant areas of the facility as well as to rejuvenate existing program areas.

2011

RVCP was awarded a Grant and Per Diem contract by the U.S. Department of Veterans Affairs to provide transitional housing services for up to 48 Veterans experiencing homelessness. Veterans are able to reside in the program for up to two years while working on the issues that led to their homelessness.

2013

Harper's Place opened January 1st, 2013. Harper's Place is a short-term residential crisis stabilization unit for up to 15 adults that are experiencing a mental health crisis. RVCP is contracted with Rock County Human Services Department to provide Harper's Place services. Harper's Place acts as a diversion to psychiatric hospitalizations as well as a step down from hospitalization.

2015

RVCP, Inc. expanded to include outpatient mental health treatment and purchased Janesville Psychiatric Clinic; which was renamed Compass Behavioral Health Clinic. This purchase allowed RVCP to begin servicing the general public, including all ages.

2016

A subsidiary company of Caravilla, Inc. purchased 1820 Center Ave. and renovated 2 vacant store fronts to house Compass Behavioral Health Clinic. This new space is not only more welcoming to our patients but it also allows room to expand the clinic's services to assist in meeting the needs of our community.

2018

RVCP was awarded two Offender Re-Entry Grants: Project TREAT and Project Employ are new programs RVCP can offer those returning to Rock County from jail or prison. We're excited to begin providing these services!

2021

RVCP opened its doors to Turning Point, a Supportive Housing Service for individuals under the supervision of the Wisconsin Department of Corrections, experiencing homelessness, and are able to regain stability with moderate intervention, assistance, and services utilization within a 60-day period.

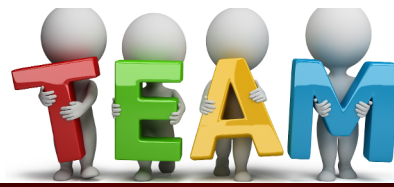

RVCP Veterans Transitional Housing

The RVCP Homeless Veterans Transitional Housing Program is designed to serve those Veterans who find themselves in circumstances that require assistance with addressing their immediate housing needs as well as other issues; things such as mental health, substance abuse and/or trauma, that have led to their homelessness. Veterans in the program could be experiencing any of the following scenarios including; being homeless on the streets, living in their vehicle, staying with friends or family on a short term basis, or transitioning out of another program with no other stable housing options.

RVCP was able to begin providing services to Homeless Veterans in April of 2011 due in large part to the generosity of individual as well as corporate donors, combined with the Capital Campaign and Grant Per Diem (GPD) from the United States Department of Veterans Affairs. Since opening on April 26, 2011 RVCP's Homeless Veterans program has served more than 500 Veterans. Our target area is VISN 12 which covers Wisconsin, the Upper Peninsula of Michigan, Northern Illinois and Northeastern Indiana, although we can serve those outside of those areas if they have ties to the local community. The Veterans cover a wide age range from those in their 20's to those well into their 80's, who have served in every war / conflict from Korea to Iraq, as well as those who served during times of Peace. This year we served 72 Veterans with our current population at 38.

This year saw continued changes in the Veterans Wing, from transitioning in my new role as Program Director, to the completion of our Veterans Department Expansion Wing. As of December, RVCP with the support of Veterans Affairs (VA), The Hendricks Family Foundation, and The WHEDA Foundation, completed renovations on a wing in the south end of the facility, to accommodate 24 single occupancy suites for veterans experiencing homelessness. This transformation has allowed RVCP to improve the transitional housing we offer to veterans resulting in less congregate housing and more individual unit style housing. These renovations will also improve the personal safety for veterans reducing the risks associated with close quarters living and increase the availability of individual unit style transitional housing.

We are truly looking forward to what 2023 will bring!

HARPER'S PLACE

In 2022 Harper's Place made a difference in the lives of 163 people in need of psychiatric crisis stabilization services.

Harper's Place has been primarily serving Rock County residents since January 2, 2013. In 2015, we contracted stabilization beds for Jefferson and Walworth County residents, as well.

Harper's Place is a 15 bed crisis stabilization unit that provides care for persons aged 18 and older experiencing an acute psychiatric crisis that does not require inpatient hospitalization. We provide services in a homelike and structured setting to help clients achieve stability.

Harper's Place stands for **Hope**
Anew **Recovery** **Peace** **Encourage**
Resilience **Strength**.

This year has been an exciting year full of changes for our program! We've enhanced programming and our staffing pattern to maximize the use of Harper's Place as a hospital diversion and/or step down to a less restrictive setting, to also include a Behavioral Health Technician Manager.

Case Managers and BHT's are staffed on all shifts and each have various roles including:

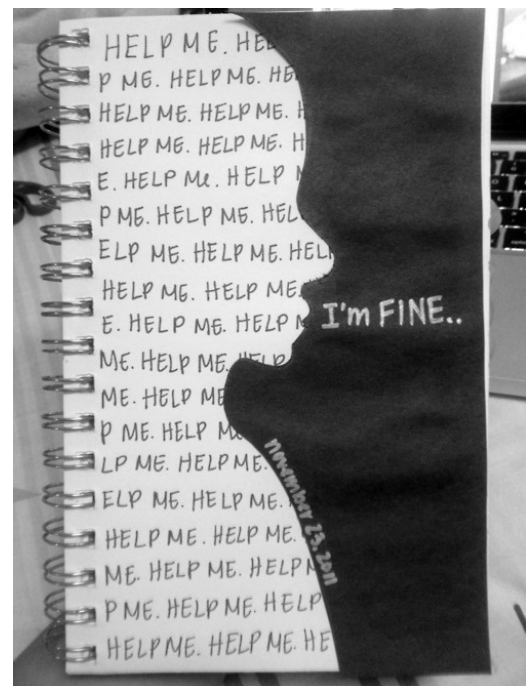
- Expertise in the area of SSDI/SSI applications and appeals as well as applying for Medicaid.
- Functional assessment of persons with psychiatric disabilities that can be used for planning psychosocial rehabilitation services and recommended level of care and services upon discharge
- Data collection of group participation, average hours of sleep, and meal reports.

A large part of our programming consists of Mindfulness Based Stress Reduction which is incorporated in clients' daily schedule at Harper's Place.

The theory behind mindfulness connects its practice to an enhanced ability to self-regulate cognitive, emotional and behavioral responses by training the brain to be in the present moment.

Some evidence supporting benefits of mindfulness include brain/immune health, improved mental health and sleep, reduction of stress and anxiety, improved attention and memory and promotes self-regulation and empathy.

Even if you feel lost or are drawing a blank.

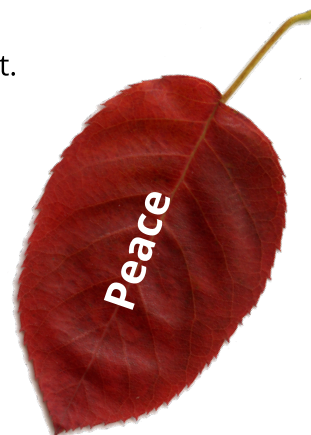

RESIDENTIAL *Reentry* PROGRAM

The Residential Reentry Program (RRP) is a State of Wisconsin Licensed Community Based Residential Facility (CBRF) with a 100 bed capacity. The program specifically serves adult criminal justice residents, male and female. Here at RVCP, we refer to the populations we serve as either clients or returning citizens. These clients are referred to RVCP by various agencies which include the Federal Bureau of Prisons, The Wisconsin Department of Corrections, and the United States Probation Office.

Each client arrives with his or her unique set of barriers and/or challenges which may make it difficult for them to transition into safe, sober, and productive independent living situations. Such things may include mental health diagnosis, various addictions, lack of housing, transportation or employment resources, lack of education or training, personal trauma, cognitive disadvantages, and many more. The RRP is staffed with a team of trained professionals that work together using a multi-disciplinary approach to help the clients to overcome such barriers and achieve personal goals. These teams are comprised of all RRP staff, from the front line Program Support Specialists to the Program Director. All of us must be consistent, positive, and supportive pro-

social role models to those entrusted in our care.

For addressing specific goals and challenges; the client works with a smaller group of professionals which consists of a designated Case Manager, Group Facilitators, Social Services Coordinator, Employment Specialist, and if applicable, a Therapist. These professionals work together diligently to facilitate the best possible outcomes for the client during their transition and/or treatment while balancing community safety and client accountability. The RRP also works closely with a multitude of other community based agencies that provide many crucial and comprehensive services that benefit the clients.

The RRP is dedicated to providing services that have been proven to work and are considered evidence-based and that uphold the integrity of the design. Some of the common evidence-based groups facilitated at RVCP include but are not limited to Employment Group, Anger Management, Thinking for Change (T4C), Moral Recognition Therapy, Carey Guides, and Wellness Recovery Action Plan (WRAP). In addition to these treatment groups, all RRP staff receive specialized training in Motivational Interviewing, Trauma Informed Care, and Core

Correctional Practices; all of which are part of a more comprehensive 12 day training academy.

In the RRP, We believe that everyone deserves a chance at redemption. We are happy to assist those that are genuine in their pursuit of self-betterment. We believe that lives can be transformed with the right opportunities and the appropriate guidance. We will continue to promote the idea of putting individuals back into the community in a better state than that in which they came to us.

In order to adhere to the directives under the Prison Rape Elimination Act (PREA), RVCP is required to publicly post all PREA violations which occurred inside its facilities annually.

In 2022: RVCP had zero PREA violations.

At first I was angry and couldn't wait to get out to keep doing what I was doing, I had plans to make it bigger than what I was doing before. Then I joined RDAP. That was one of the best decisions I ever made in my life. My life was totally transformed for the better. Thanks to DTS staff especially Mr. Guzman, I finally got my mind right. His style of counseling is what really opened my eyes. Then I got out of prison and went to a halfway house in Janesville Wisconsin, RVCP, where I am doing my aftercare. Here I would like to thank my case manager and my therapist for making my transition back into society a successful one and also for having someone who really cares for my wellbeing and having someone that I can talk to about my feelings and get honest feedback. So now I enjoy working a honest job and being able to help my family the right way with hard work and dedication. I also learned to express my feelings and how to ask for help when I need it.

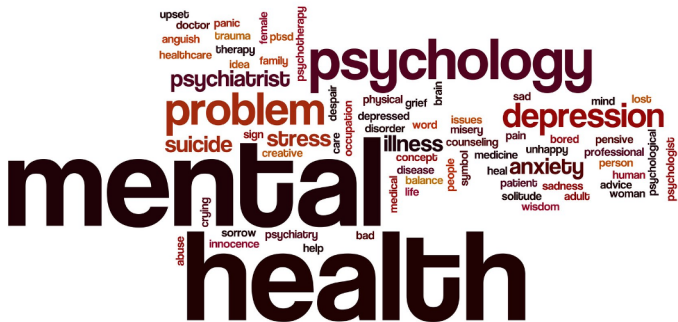
HEALTH CLINIC

COMPASS BEHAVIORAL HEALTH CLINIC (CBHC) - SITE 1 (Sunny Lane Rd.)

CBHC site 1 focuses primarily on providing correctional behavioral health services to State of Wisconsin Department of Corrections (DOC) and Federal Bureau of Prisons (FBOP) clients residing in RVCP's Residential Re-entry Center (RRC). The majority of site one's therapists hold dual licenses, allowing them to provide both substance use disorder counseling and mental health counseling to the correctional clients. Compass Site 1 also has two therapists that are Certified Sex Offender Treatment Professionals.

Some of the most significant changes for site one this year were implementing the MRT curriculum for the State DOC programming, and sex offender group programming for the United States Probation (USPO) clients. As of 10/8/2022 Compass Site 1 has served 459 clients ; 438 identified as male and 21 identified as female clients.

COMPASS BEHAVIORAL HEALTH CLINIC (CBHC) - SITE 2 (Center Ave.)

CBHC site 2 focuses on providing the highest quality of care to clients that are struggling with mental illness and/or addiction. CBHC Site 2 is a non-for-profit private clinic that provides evidence based services to the general community in an outpatient setting. CHBC Site 2 continues to be in the forefront of treatment being one of the first clinics in this area that provides comprehensive substance use disorder treatment, specifically designed to help address the opiate addictions epidemic that continues across our nation.

CBHC Site 2 has staff that are dedicated to help navigate client's roads to success. These individuals include administrative staff, a wonderful team of five therapists, and one Advanced Practice Nurse Prescriber (APNP). Two of our therapist are Licensed Professional Counselors (LPC), one is Licensed Clinical Social Workers (LCSW), and two have Substance Abuse Counseling licenses (SAC/CSAC) in addition to their mental health counseling licenses.

Current behavioral health services offered at Compass Behavioral Health Clinic include:

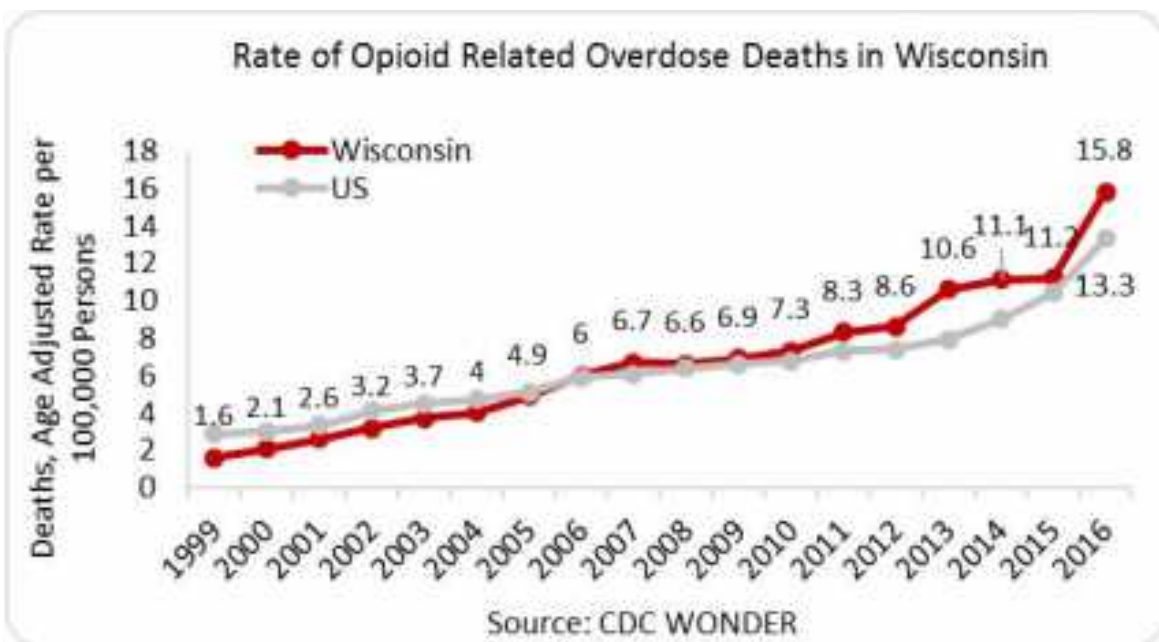
